**ORDER NO. A1/7799/10 Dated, 27.12.2010.**

The following P.D. Teachers/LPSA's/UPSA's are provisionally promoted as H.S.A. (Core Subject) for the year 2010-11 and posted in the school noted against their names. The Head Master concerned will verify the original certificates of the incumbents and ensure that they possess the qualifications. The service details of the teachers are also to be verified and ascertain that the promotee is fully qualified as on 01.4.2010 to hold the post of H.S.A. (Core Subject). In the case of qualifications acquired from Universities outside the State Eligibility Certificate issued by any of the Universities in Kerala should be insisted. In the case of qualifications are acquired through regular study in service, the Service Book of the concerned teacher should be verified so as to ascertain whether study leave has been availed for the same. If any of the teacher is found not been qualified for the promotion, they should not be relieved and same should be reported to the undersigned immediately.

The Head Master of Government High Schools to which the teachers posted will also satisfy themselves of the qualifications of the promotees before they are permitted to join duty.


The promotees should join duty on or before 12.1.2011 failing which they will forfeit their chance for promotion to the post and the resultant vacancy will be filled up by the next eligible person in the seniority list. The teachers who are willing to relinquish temporarily for one year or permanently the promotion, it should also be done within the above date in the prescribed Proforma through the Head of Institution.

The Head Masters concerned will report the date of joining duty ~~on~~ joining duty of the promotees immediately on expiry of the time limit. They are also directed to make necessary entries in the Service Book of the teachers concerned. The date of entry into service as H.S.A. as per this order and also record the certificate of verification of qualification.
